5 (J) The department shall establish an Independent Workers'
6 Compensation Pharmacy and Therapeutics Committee that shall
7 select a nationally recognized, evidence-based prescription drug
8 formulary appropriate for resolving issues related to drugs
9 prescribed for or related to the treatment of work-related
10 injuries, including, but not limited to, the type, dosage and
11 duration of prescriptions. The following apply:

12 (I) The committee shall consist of eleven members, including
13 the secretary or a designee as the nonvoting chairperson, four
14 physicians, four pharmacists, one physician's assistant and one
15 registered nurse practitioner. A committee member shall have
16 knowledge or expertise in one or more of the following:

17 (A) Clinically appropriate prescribing, dispensing and
18 monitoring of covered prescription drugs.

19 (B) Clinically appropriate health care delivery, including,
20 but not limited to, pain management, pharmacy practice, medical
21 quality assurance, disease management and utilization review.

22 (C) Clinically appropriate addiction treatment.

23 (II) Committee members shall not be employed by a
24 pharmaceutical manufacturer, a pharmacy benefits management
25 company, an insurance company or a company engaged in the
26 development of a pharmaceutical formulary for commercial sale
27 during the members' term, and shall not have been so employed
28 for twelve (12) months prior to appointment.

29 (III) Immediately and by January 1 of each year, committee
30 members shall submit to the department a sworn statement of
31 financial interest on a form prescribed by the department.

32 (IV) A committee member may be disqualified for any
33 substantial conflicts of interest.
